The International Atomic Energy Agency (IAEA) will hold the Consultancy Meeting on Recycling of Plastic Wastes Using Radiation Technology (hereinafter referred to as "event"), which had to be postponed owing to the COVID-19 pandemic, virtually via Cisco WebEx from 27 to 30 October 2020.

The purpose of the event is to discuss the latest achievements in the recycling of plastic wastes using radiation technology, and to propose a possible coordinated research project.
